Funds deposited directly into your checking or savings account through EFT are available to you earlier than funds received by paper check through traditional mail delivery.

To set up direct deposit by EFT please complete these three easy steps:

- 1) Complete and sign the attached authorization form. This form allows FME to make EFT payments to your account.
- 2) Attach a voided check or deposit slip to the authorization form. The voided check or deposit slip enables FME to verify the financial institution name and routing information on your form.
- 3) Return the completed authorization form and attached voided check or deposit slip to FME for processing.
